He was passionate about Jewish experiential programming, particularly trips to Israel and Jewish sponsored overnight camps. As a tribute and memorial to Sam, the Federation Board of Directors established the "Sam Kooperman Endowment." Dual purposes of the fund are 1) to provide scholarships for Jewish overnight camping experience for Jewish youth; and 2) to provide scholarships for Jewish young adults to study in Israel. In both cases, it is for those who reside in the Mahoning and Shenango Valley region.

If the Grantee is required to leave the conference/program/camp early due to illness, behavioral issues, or any other reason deemed appropriate by the conference organizers or the Grantor, the Grantee agrees to reimburse the Grantor on a pro rata basis for the portion of the funding corresponding to the missed portion of the event.*

*Repayment must be made within thirty (30) days of the Grantee's notification of non-attendance or early departure. If full repayment cannot be made within that 30-day period, a repayment plan must be submitted to, and approved by, the Youngstown Area Jewish Foundation's Financial Resource & Development Director within the same timeframe.*
